










PALESTINIAN CASUALTIES BY WEAPON 1 JANUARY 2024 - 31 JANUARY 2025



PALESTINIAN CASUALTIES BY GOVERNORATE 1 JANUARY 2024 - 31 JANUARY 2025



 read; 13 travelis were killed by Palestinians from the West Bank in attacks that also resulted in the killing of 5 Palestinians between January 2024 and January 2025, with no such fatalities recorded in January 2025. These are counted separately, as this report covers incidents that took place in the West Bank who have been documented by OCH4 since 2005, settler violence since 2006, and demolitions and displacement since 2009.

 Similars or Israelis whose immediate cause of death or the perpetiator's identity remain disputed, unclear, or unknown, are counted separately, so are casualties as a result of "friendly fire" and Palestinian prisoners from the West Bank who have died in Israeli custody. Figures also do not include UXOs, mish, sons, hit-and-run incidents, internal Palestinian clashes, and incidents where the perpetrator's nationality is disputed.




