

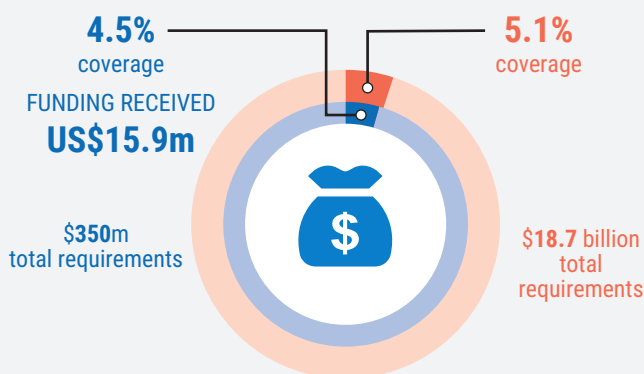
## OVERVIEW

The 2019 Humanitarian Response Plan (HRP) requirements are only 4.5 per cent funded to date. Without adequate funding, humanitarian partners will struggle to respond to the needs of people affected by crisis across the oPt.

\*This does not include some \$12.4 million funding received for the HRP that has yet to be allocated by type of activity.

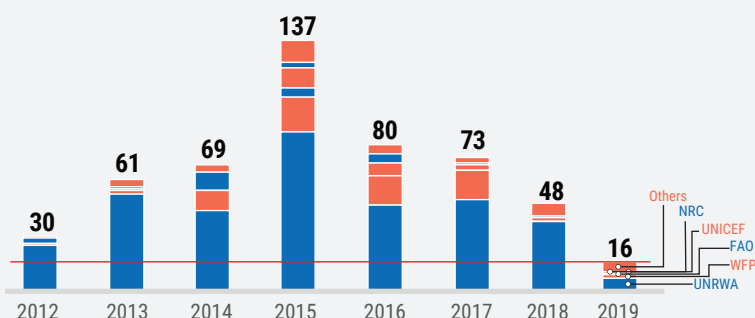

Humanitarian funding in 2019 is significantly lower as compared to the same period over the last seven years. The decline since 2018 in funding for UNRWA, the single largest humanitarian actor in the oPt, has been a key contributing factor. However, nearly all agencies in the HRP have received less funding in 2019, as compared to previous years, negatively affecting the majority of the humanitarian operation in the oPt.
